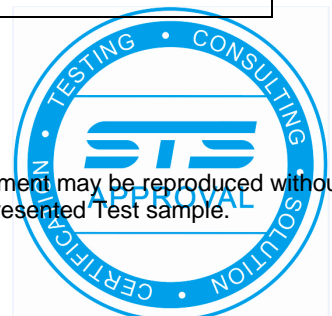

Section 4 – First-aid Measures

Inhalation	If contents of an opened battery are inhaled, remove source of contamination or move victim to fresh air. Obtain medical advice.
Skin contact	If skin contact with contents of an open battery occurs, as quickly as possible remove contaminated clothing, shoes and leather goods.
